

Students with disabilities have equal access to courses, programs, services, jobs, activities, and facilities available through WGTC, and must meet the college's qualifications and essential technical, academic, and institutional standards.

What are accessibility standards?

Accessibility Services provide students who have a documented disability with accommodations to aid them in the learning process at West Georgia Technical College.

How do I sign up for Accessibility Services?

Students should contact the Accessibility Services Coordinator and schedule an intake interview. During this session, students can_submit_documentation of their disability. Services are usually not provided until the completion of the intake interview.

*Generally, an IEP or 504 Plan without additional documentation doesn't constitute complete supporting documentation of a disability.

WGTC does not conduct the evaluation of a disability and does not pay for such assessments, but Accessibility Services can provide information to start the evaluation process.
